Eligibility Criteria



Individuals

- May be of any gender, caste or creed and citizen of India
- Aged between 21 to 65 years
- Passed Minimum 10th from any Board/School
- Should have good social conduct and sound mental health

Partnership

Each partner should individually meet the eligibility criteria except for land & finance


Non-individual entities

- The entity should be registered in India.
- Entity will have to furnish appropriate Board Resolution/Power of Attorney to show that person making the application on its behalf is empowered to make the same.

The applicant should be financially sound to make the initial investment to the tune of Rs.1 Crore and organize working capital.

The applicant should have land by means of ownership (whether with title deed or lease holder) or having the firm offer from the landowner (s) to lease the land directly to the individual.


*Government Bodies/Agencies, Societies registered under Societies Registration Act 1860 / Societies registered under Co-operative Societies Act, 1912 or Co-operative Societies Act as enacted by concerned States, Charitable Trusts registered with Charity Commissioner of respective State Government, Companies formed under the Companies Act, 1956 / 2013, including Private Limited companies






Land & Lease requirements




- The offered land should be situated on the main road frequented by Auto Rickshaws and Cars running on Auto LPG.
 - Minimum Area requirement: 625 Sq meter with Frontage of 25 Meter.
 - In case a plot of smaller dimension meets the statutory norms and IPPL requirements, the same can be considered on a case-to-case basis.
 - Plot situated on National Highway should comply with MoRTH norms. Consideration of plots on NH will be subject to leaving applicable ROW (Right of Way) as per the norms.
 - Plot should be abutting to the road, and there should be no Overhead High Tension (>11 KVA) Line on the land.
 - The land should be Non-Agricultural, designated as a Commercial or Industrial Plot. It should have a clear legal title, free from any encumbrances and encroachments.
 - Any fees associated with NA (Non-Agricultural)/NOC (No Objection Certificate)/Zoning regulations, etc., required for setting up an Auto LPG Station, shall be borne by the applicant.

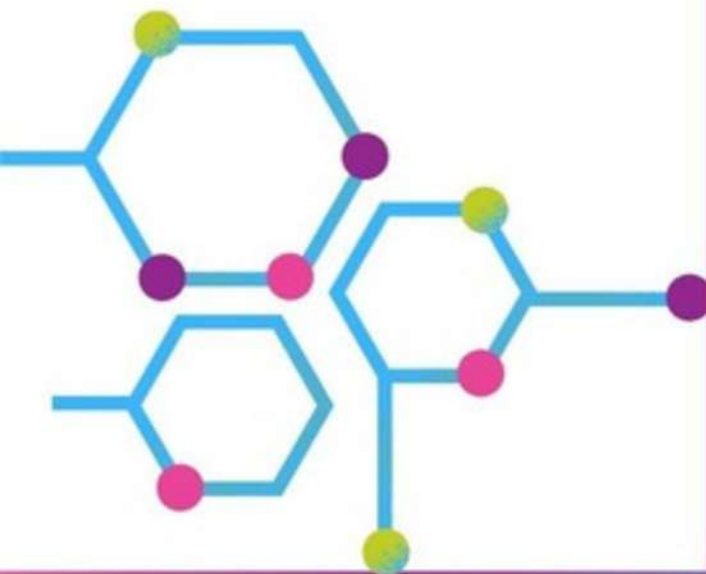



Construction of ALDS as per IPPL standards

Permissions & Approvals



The applicant needs to obtain all statutory approvals required to set up Auto LPG Station including No Objection Certificate (NOC) from District Collector/Commissioner of Police (as applicable), Town Planning approval, any other local authorities' approvals, Highway (if applicable), Change of land use (CLU) to Non-Agriculture (Commercial) and arrange for Electricity Connection & Water Connection.






Selection Process



Applicant to submit Expression of Interest (EOI)* on IPPL website www.indpet.com > Business Opportunity > ALDS Dealer

IPPL shall carry out assessment of the site for technical feasibility, business potential and related business parameters. Sites shortlisted shall be taken up for further evaluation.
